~ First developer in Melaka to offer solar-ready homes in building a sustainable township.

Teladan has appointed MEH as the turnkey engineering, procurement, construction and commissioning ("EPCC") provider for the project. MEH has extensive experience in delivering comprehensive solar PV systems solutions for residential, commercial and industrial users.
